For simplicity, we will assume here that  $x(t) \in \mathbb{R}^n$  (so  $F = \mathbb{R}$ ), and that  $f(t, x)$  is continuous in  $t$ , and uniformly Lipschitz in  $x$  (with Lipschitz constant  $L$ ) on  $[a, b] \times \mathbb{R}^n$ . So we have global existence and uniqueness for the IVP on  $[a, b]$ .
